

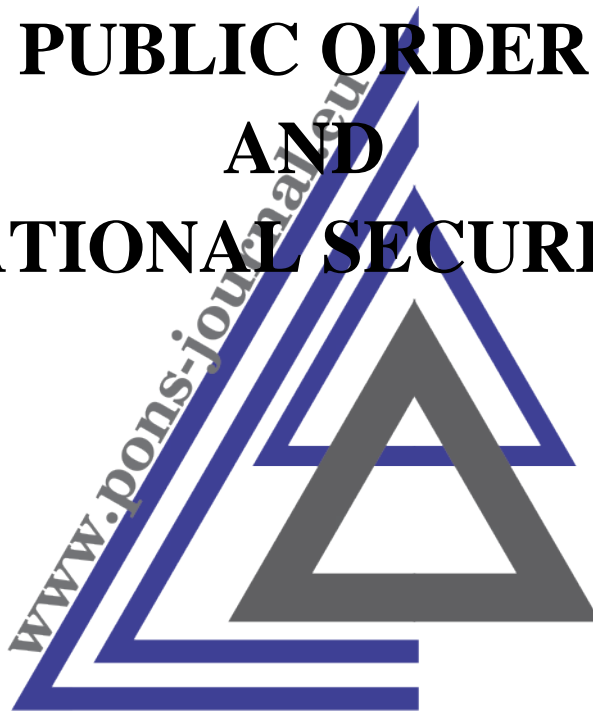

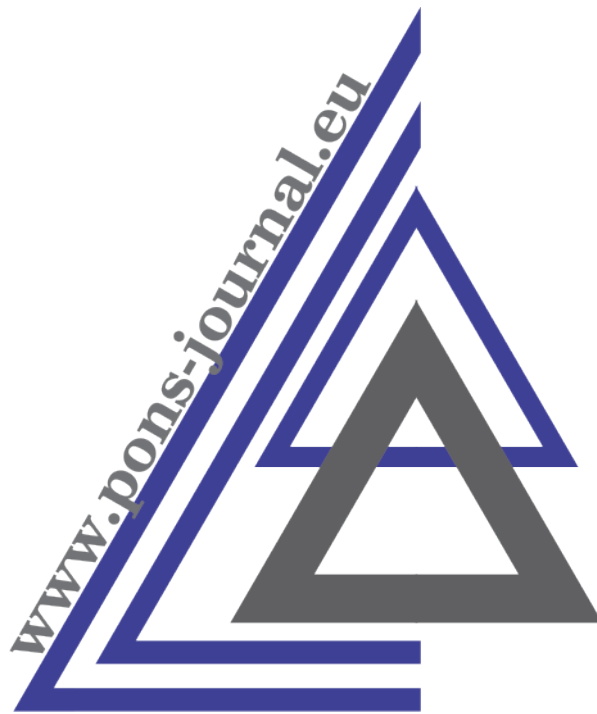

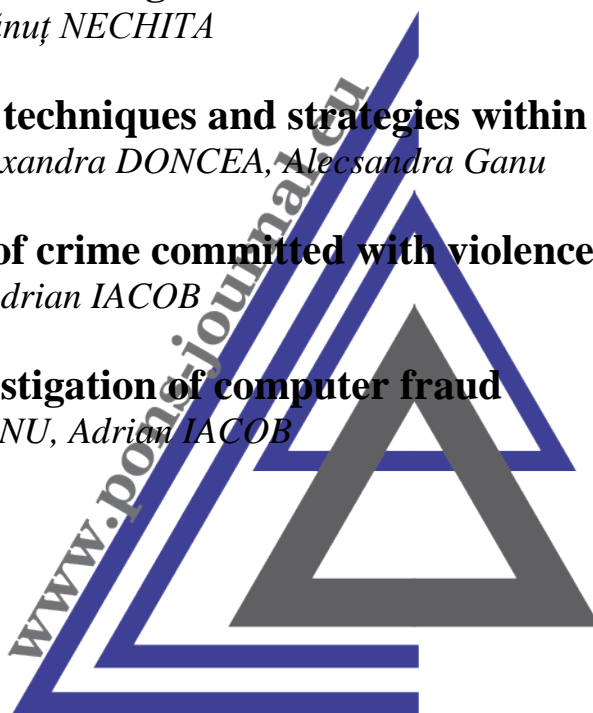

ABSTRACT

Defining the terrorism and terrorists makes the object of investigation and understanding the phenomenon which has worldwide developed. International terrorists, unable to achieve their goals through conventional means, try to convey an ideological or religious message by terrorizing the general public. By choosing their targets, which are often symbolic or representative for the nation concerned, the terrorists are trying to create a strong impact on the enemy public by violence, despite their scarce material resources they have available. Through this they hope to demonstrate much more so as the concerned government or governments to be not able to protect its citizens; or by the assassination of certain victims, they can give generally a lesson to the public. For example, by the assassination of the Egyptian President Anwar al-Sadat on October 6th, 1981, one year after his important trip in Israel, the Al-Jihad terrorists had hoped to persuade the world and especially the Muslims that it was committed a great error.

ABSTRACT

In Romania, the legal lawful framework regarding the illicit circuit of the narcotic substances is provided by the Law No. 143/2000 on combating the drugs illicit trafficking. In this regard, in order to ensure the compliance with the legal provisions on narcotic substances, are specifically designated compartments within the police that, according to the duties they have based on the laws in force and through the cooperation with specialists from the Ministry of Health, General Directorate of Customs and with other units of the Ministry of Home Affairs, which have the right and duty to monitor and control the activity with narcotic substances in all the segments of the legal circuit and act to combat the illicit trafficking.

ABSTRACT
